



Ugly Sweater Giveaway Official Rules

These are the Official Rules for the Midwest Regional Bank's Ugly Sweater Giveaway running from 12-1-2020 to 12-16-2020 (8:30 pm cst). By entering the Giveaway, entrants agree to comply with and be bound by these Official Rules.

1. How to Enter Midwest Regional Bank's Ugly Sweater Giveaway: All persons who like the official Midwest Regional Bank Facebook page and tag a friend on the original giveaway post will be entered into the drawing. Winner will be chosen at (8:30pm cst) each evening.
2. Winning Entry Prize: The winning prize entry will be drawn following the Promotion Period (each business day for 12 days), via a random selection process from the pool of eligible entries. Entrants selected must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. Only one prize will be awarded each day. All decisions of Sponsor are final and binding with respect to this Giveaway. The prize for the Sweepstakes winner: 1 Sweater sized XL
3. Notification and Redemption: A Midwest Regional Bank representative will notify the winner by 12-22-2020. Winner is subject to eligibility and age verification. If the drawing winner cannot be contacted within 48 hours after the first attempt to contact him/her, or if he/she fails to satisfy all conditions to acceptance, Midwest Regional Bank may select an alternate entrant at random from among remaining eligible entries. A winning entrant is only a winner after notification by the Sponsor and compliance with the terms and conditions of these Official Rules, as determined by Midwest Regional Bank.
4. Conditions to Acceptance of Prize: By accepting a prize, each winner consents to the use of his or her name and photo in advertising without additional compensation. Winner shall bear any and all costs associated with participating in the Giveaway or winning the prize. All applicable taxes, including any federal, state, or local tax liabilities, are the sole responsibility of the winner(s) and the winner(s) may receive an IRS form 1099 for the approximate retail value of the prize.

There is a limit of one entry per qualified entrant during the promotion period. Qualified entrants are limited to legal residents of Missouri who are eighteen (18) years of age or older on the date of entry. Employees of Midwest Regional Bank and their families are not eligible.
